Candidates

Allyce Bailey (Columbia): Reflecting over my involvement with SCWLA, I realized that I have actually been a member longer than I have been a lawyer! I was privileged to serve as the first Executive Director of this great organization that embraced me before I even obtained my bar roll number. In my role as Chairperson of the Community Outreach Committee, I have found immeasurable gratification over the last three years planning statewide service projects to better the communities in which we live. During my tenure as Chairperson, the Committee has assisted with refurbishment efforts of women's shelters, coordinated a toy drive that enabled every single child involved with Court Appointed Special Advocates to receive their personal Christmas wish, and even organized a flood relief effort that in part garnered SCWLA national recognition as we were awarded the National Conference of Women's Bar Association's Outstanding Member Award for our "Resilience Project." I have a unique perspective regarding the issues facing the organization and believe that I would be an asset to the Board. In addition to her work in the South Carolina Bar and professional associations, Julie was a Commissioner on the State Ethics Commission from 2014 to 2017, and she is active in many community organizations.

Nancy Olah (Fort Mill): Nancy Olah is a transactional attorney focusing on commercial real estate, sustainable development, construction law, and business transactions at Nancy Olah Law.
